



## Terms and conditions HotelSummit 2026

### Monday, 9 november 2026

#### Article 1. Applicability

1. These general terms and conditions apply to the congress HotelSummit on Monday, 9 november 2026, in Bunnik.
2. Deviations from and/or additions to these general terms and conditions shall only be valid insofar as they have been agreed in writing.
3. If one or more of the provisions in these general terms and conditions should at any time be wholly or partially void or nullified, the remaining provisions of these general terms and conditions shall remain fully applicable.

#### Article 2. Definitions

1. In these general terms and conditions the following definitions shall apply:
  - a. Congress: HotelSummit, Monday, 9 november 2026, Bunnik.
  - b. Participant: the natural person who has registered for participation in the congress in a manner permitted by the organiser.
  - c. Registration: the acceptance by the participant to participate in the congress by sending the registration form on the website [www.HotelSummit.nl/registreren](http://www.HotelSummit.nl/registreren).
  - d. Organiser: Uitgeverij PS: bv, located at Leijenseweg 111F, 3721 BC in Bilthoven, registered with the Chamber of Commerce under number 30151103. Telephone number 030 251 22 70.
2. These general terms and conditions apply to every registration.

#### Article 3. Liability

1. The organiser excludes any liability for the congress not taking place or changing the date of the congress.
2. The organiser excludes all liability by whatever name for damage arising as a result of registration, payment or participation in the congress, insofar as he is not obliged to pay compensation for such damage according to mandatory statutory provisions. In the latter case, the participant is obliged to prove the liability and the indebtedness of the payment.
3. In the unlikely event that the organiser has any obligation to pay on account of liability, the organiser will only accept liability up to the amount of the congress fee or to the extent and if more the amount that any liability insurance of the organiser will pay out.
4. The organiser will not accept any liability for mistakes made by third parties engaged on behalf of the participant, such as but not limited to the speakers, the legal and actual management of the congress location.
5. If the organiser suffers damage as a result of an act or omission to act on the part of the participant, the participant will be liable for the damage resulting therefrom and such damage will be recovered by the organiser from the participant. The participant hereby indemnifies the organiser against all claims, as referred to above.
6. The organiser is not liable for loss, theft or damage of property during the congress.

#### Article 4. Participation

1. The participant may participate in the congress only if:
  - a. the participant has completed the registration form in full; and
  - b. the participant meets the target profile; and
  - c. the organizer has received the full congress fee; and



- d. the participant has agreed to the applicability of these general terms and conditions.
2. Registration may be cancelled. After registration, cancellation is possible by sending an email to [carina.thaens@uitgeverijps.nl](mailto:carina.thaens@uitgeverijps.nl). In that case, the congress fee will be refunded. Cancellation with refund is possible up to three weeks before the date of HotelSummit. After that, no refund is possible. After registration, the participant will receive an e-mail from the organiser confirming his/her registration for the congress.
3. After registration, the participant will receive a confirmation of their congress registration by email from the organizer.
4. HotelSummit is exclusively for hoteliers, hotel owners, general managers, hotel managers, CEOs or CFOs. Executives of real estate companies, management agencies and project developers with demonstrable hotel properties in their portfolio are also welcome. Each registration will therefore be carefully reviewed and followed up. The organization reserves the right to decline registrations.
5. The organizer accepts no correspondence or liability regarding exclusion if a registration does not meet the required profile.

#### **Article 5. Cancellation**

1. The organiser of the congress has the right to cancel the congress at any time on the grounds of serious or exceptional circumstances. In addition to force majeure situations preventing the congress from going ahead, serious or exceptional circumstances are understood to include the existence or emergence of a situation in which the safety of one or more participants is at risk.
2. If the organiser decides to cancel the congress on the grounds of a serious or exceptional circumstance, the congress will, if possible, be rescheduled to another date or location. The participant's registration will in that case be moved to this new date or location.
3. The organiser will inform the participant without delay of any rescheduling or cancellation of the congress. To this end, the contact details of the participant known to the organiser will be used.
4. Should the congress be postponed or cancelled, the organiser will not be required to pay any compensation to the participant, including but not limited to reimbursement of costs incurred by the participant in connection with participation in the congress, such as travel and accommodation costs.

#### **Article 6. Personal data**

1. The personal data provided by a participant will be recorded in a file by the organiser. By participating in the congress, a participant grants the organiser permission to use the personal data for sending information to the participant. The organiser will process these data with the greatest care and will not make them available to third parties without the express permission of the participant other than the third party engaged by the organiser for registering the participants and for providing a list of participants to the sponsors. Only the company name, name and position of the participant shall be mentioned on the list of participants.
2. During the conference, a conference app will be used. When the participant registers for this app, the company name, name, and job title will automatically be visible to other users. This visibility can be switched off at any time.

#### **Article 7. Portrait rights**

The participant grants permission in advance to the organiser for publication of photographs and visual material made during or around the congress, on which the participant is visible. The organiser



is in any case entitled to use the photos and visual material for promotional purposes. In addition, the photographer has the right to place the photos on his site via 'flickr'. The participant shall not oppose the use of the photos and visual material, nor shall the participant demand compensation from the organiser for this purpose.
